# Pro-Animal Colorado to Submit Over 16,000 Signatures for Denver Ballot Initiative to End Force-Fed Foie Gras

After a remarkable grassroots effort across the city, Pro-Animal Colorado will submit **more than 16,000 voter signatures** to place the Prohibit Force-Feeding Birds Act on Denver's 2026 ballot. Since January, **84 volunteers** collectively spent **over 2,000 hours** gathering signatures from Denver voters who want to see the city end the sale of products derived from force-fed birds.

The proposed measure would prohibit force-feeding of birds and the sale of force-fed foie gras. A practice defined in the petition as inserting a tube into a bird's esophagus to deliver excessive feed, causing pathological liver enlargement and severe animal suffering. Although there are no foie gras farms in Denver, the Act would prevent such operations from opening in the future and ensure that businesses cannot sell foie gras sourced from force-fed birds.

**If certified,** the initiative will give Denver voters the opportunity to decide whether the city should end the commercial sale of products derived from force-feeding. The campaign emphasizes that the measure addresses animal cruelty, worker safety, environmental impacts, and public health.

If approved for the ballot and later passed by voters in November, the law would take effect July 1, 2027
